Short Application Guidelines and Key steps in the processing of an application for Consent to Mortgage (MOT)

1. A BO Title Holder who wants to apply for Consent to Mortgage must apply with this MOT form.
2. The Applicant must also complete a UFI OR UFO form with the details of the Bank (Mortgagee).
3. The Consent to Mortgage attracts an Application Fee of **N5,000**. This Payment is non- refundable and must be paid into **BOGIS Zenith Bank Account 1017010815**. The Bank Teller/Receipt must be submitted together with the completed Application Form.
4. Fees for Registration and Stamping will be applicable once the consent has been approved. These are 2% of the Consideration and Added Amount respectively. The amounts will be communicated as soon as they become due.
